- For Abscess refer to Abscess Management. IV therapy will only be funded for an Abscess where endorsed by Infectious Disease (ID) consultant. Abscess should be managed with I&D.
- Funding of more than 3 doses must be endorsed by ID consultant. The name of consultant should be documented in clinical notes.
- Price inclusive of GP/Nurse time and consumables
- Cephazolin is PHARMAC funded and can be sourced from pharmacy on prescription or from your normal medical supplies company
- IV Cephazolin is **not** funded by POAC for any other condition.
- If known injury/trauma (insect bite, stings, infected tattoo, post op infection, scratch etc) submit claim under ACC.
